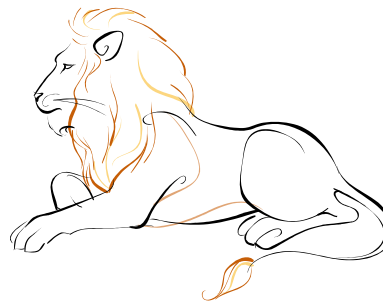

All of CKM's LPPA partners are focused on one thing – providing exciting opportunities for McClatchy students in the legal field. Our partners include:



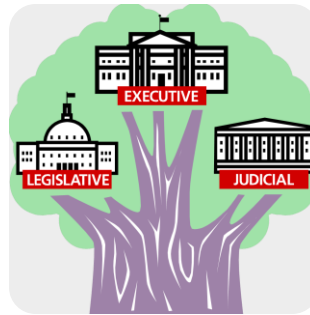
